CSSD Annual Employee Recognition Awards

Prior to his retirement, former Director of Adult Services, Greg Halzack talked about and envisioned a yearly event to recognize and celebrate staff for their hard work, accomplishments and distinguished service to the Branch. A committee comprised of Adult Services field staff, supervisors, and central office administrators was created to develop and implement Greg's employee recognition concept. To that end, the committee established individual awards for Adult Probation and Bail Services staff.* Subsequently, Juvenile Probation and Family Services followed with their own such awards. This issue of "The Chronicle" will highlight the distinguished honorees that were recognized in Bail, Adult Probation, Juvenile Probation, and Family Services.

The awards given in Bail Services are: Bail Officer of the Year, Support Staff or the Year, Bail Supervisor of the Year, and the Ann McKenna Award for Outstanding Contribution, which was added in 2015. The Ann McKenna Award is a special recognition of a staff member who exemplifies the virtues by which Ann lived—honesty, dependability, dedication, a positive attitude, and a willingness to help others.

The awards given in Adult Probation are: CPO of the Year, APO of the Year, Support Staff of the Year, and Certificates of Merit, which include the categories of Distinguished Service, Outstanding Act, Community Service, and Valor. Juvenile Probation presents the following awards: Going the Extra Mile, Risk Reduction Warrior, Leading by Example, Super Support Staff, and Community Champion. Family Services distributes the Team Player and Above and Beyond the Call of Duty Awards.

Sara Barron, Manager of the Jail Re-Interview Program, emphasized the value of these awards by explaining that "the consistent heartfelt, meaningful small things, not grand gestures, are a very important piece of the puzzle. Our jobs are not just to manage people, but to celebrate them." Sara also noted that Mike Hines, Assistant Director of Bail Services, who has been instrumental in carrying on this tradition from year to year, is someone who exemplifies that notion. He leads by example and models the behavior that he wishes to see in his team members. The employee recognition awards are meant to give us all the opportunity to shine a light on the people at CSSD who inspire us to do our best. Overall, the awards enhance morale, foster cohesion, promote accountability, and acknowledge excellence.

Congratulations to all of our esteemed honorees and thank you for your dedication to the Branch and all the people we serve.
