## **National Recognition of a CT Expert**

From his work over the years in CSSD Juvenile Detention, and as recent Superintendent of the Bridgeport and later the New Haven Juvenile Detention Centers, Karl Alston has been very instrumental in bringing about the many positive changes in detention that have resulted in CT's system being recognized and accredited as one of excellence by the American Correctional Association 2003. Now in his current position as Deputy Director of CSSD Juvenile Residential Services, Karl was named as the East Region Vice President of the National Juvenile Detention Association (NJDA) in October. As noted by Michael Jones, Managing Director of the NJDA, "a membership-based association is only as strong as the members who maintain an active involvement and who provide their collective support in guiding the organization. The Association needs hard working, committed leaders (like Karl).... to continue to grow and work to ensure that the Association's principles, standards and philosophies of juvenile detention are sustained."

The National Juvenile Detention Association, founded in 1968 exists exclusively to advance the science, processes, and art of juvenile detention services through the overall improvement of the juvenile justice professional. In 2004 the Association merged their membership organization with the Council for Educators of At-Risk and Delinquent Youth (CEARDY), the Juvenile Justice Trainers Association (JJTA), and the National Association for Juvenile Correctional Agencies (NAJCA) under the one NDJA operational entity. In 2007 a fifth organization, The National Association for Children of Incarcerated Parents (NACIP) also came into the partnership.

The NJDA has also forged an association with the National Partnership for Juvenile Services (NPJS) www.npjs.org. The National Partnership provides professional development and technical assistance and promotes best practice and standards to the juvenile justice field that will positively impact youth, families, and communities. One of the special initiatives that the NPJS is currently involved with includes the Juvenile Detention Alternatives Initiative (JDAI), a project of the Annie E. Casey Foundation. The NJDA is also supporting this Initiative. The project is dedicated to demonstrating that jurisdictions can safely reduce reliance on secure detention and strengthen juvenile justice systems through the use of inter-related reform strategies that include use of evidence based practices, gender and culturally appropriate strategies and behavioral motivation techniques which are some of the enhancements that have been made in CT's residential and services detention system that Karl has been involved in implementing www.aecf.org.. The National Partnership is also committed to ending the practice of trying, sentencing, and incarcerating children under age 18 in the adult criminal justice system. CT is poised to join this movement with the implementation in 2010 of legislation that will raise the age of juvenile jurisdiction to include 16 and 17 year old adolescents who are currently handled in the adult system.
