Editor's Note: During November and December, many CSSD offices and personnel participated in community outreach activities such as food, clothing, and gift drives. This special edition of the Chronicle highlights and celebrates the many, many ways CSSD personnel helped to make this year's holiday season a better one for those in need.—Linda Grzeika

It was only two weeks before Thanksgiving when Gerald Davidson and Thomas Willingham, who work at the Hartford Juvenile Detention Center, decided to donate money to Hartford Food Share to help the charitable organization buy turkeys for area families. Other Detention Center staff heard about the duo's generosity and also wanted to help. According to Davidson and Willingham, over 50 detention staff, and two juvenile probation officers, joined them to contribute \$630 to Food Share. The collected money purchased 48 turkeys for Thanksgiving dinners in the Hartford area. "Next year, we're going to start collecting earlier!" the men said. "A lot of court and probation staff came up to us afterwards and told us they would have contributed. It looks like this will be a yearly event that will include all of our court, juvenile, and detention staff."

The New Haven Family Relations Office has a long history of community outreach activities throughout the year. A strong supporter of local domestic violence agencies, employees participate in fund-raising activities such as a yearly bowl-a-thon and "Purple Tie Tuesday" which helps raise funds to provide critical services for individuals and children affected by domestic violence. During the holiday season, staff participate in the New Haven Home Recovery's Adopt-A-Family Program. This year, the office was matched up with a single parent, six child home. New Haven Home Recovery

identifies each family member and child by age and gender with specific items they request. The list is disseminated to staff who sign up to purchase an item. New Haven Home Recovery delivers the gifts to the family, allowing the parent to wrap and distribute the gifts to the children. This process allows the parent to participate in the giving. The gifts and donors remain anonymous. "I am very proud of my staff," said Charles "CJ" Forcier, Supervisor I. "This is another example of the commitment they have toward their profession and the community they serve." Other family relations offices participate in yearly holiday charity events including Harford, which adopts a family identified through the Salvation Army and provides gifts for them.

Juvenile probation staff in Bridgeport are involved in several gift and food drives during December including an interesting grab bag gift campaign where probation officers purchase toys for one another, based on what they think best fits the recipient's personality, as part of the office's holiday party. Then, all of the toys are donated to the local Toys for Tots Program. Nicole Messina, who is currently a senior at Sacred Heart University and an intern at the Bridgeport office,

drive for two women and children's programs. *Fresh Start* in Hartford and *Elm City Women's and Children's Center* in New Haven identify mothers and their children and provide a list of toy requests and clothing needs. Central Office staff choose one or more items to purchase and wrap the gifts, topping them off with an identifying tag. Over fifty items are donated each year. This holiday season, the request tags, which were written on paper mittens and posted on each floor, were taken by staff within hours and wrapped presents decorated the halls within days. The gifts have already been picked up and will be distributed in the days leading up to Christmas.

For a second year in a row, the officers and staff at the Waterbury Adult Probation office have fulfilled the requests of another women and children's program, *The Chase Center*, in Waterbury. Probation Officers Deanna Recchia and Allison Chance spearhead the effort in their office by posting the program requests, collecting the items, and delivering them to the center for distribution. "The response from our officers is amazing," said Recchia. "Everyone goes above and beyond to make sure the gift and clothing requests are fulfilled. This year, we were able to provide for six children at the center."

CSSD Executive Director William Carbone notes, "This special edition of the *CSSD Chronicle* has highlighted only some of the charitable events that have involved CSSD personnel during this holiday season. We know that other activities are undertaken, and we applaud all those efforts."

May the holidays deliver an abundance of happiness and good cheer to all our *Chronicle* readers, and may that joy continue throughout the New Year.
