1. OLD BUSINESS

The committee took note that Judicial Branch Financial Services had calculated that \$353,596.53 will be made available from the client security fund for lawyers' assistance program spending during the calendar year 2025 pursuant to Practice Book § 2-77.

2.4. Letter dated February 28, 2025, from the Chief Court Administrator to the Rules Committee of the Superior Court Requesting an Amendment of Practice Book § 2-77

The committee took note of the Chief Court Administrator's letter dated February 28, 2025, to the Rules Committee of the Superior Court requesting an amendment to Practice Book § 2-77 to increase the amount from the client security fund in any calendar year to be made available for the lawyers' assistance program. Judge Moll advised the committee that, at the March 17, 2025 meeting of the Rules Committee, the Rules Committee voted to submit the proposal to public hearing.

2.5. Practice Book § 2-77, Recommendation to the Chief Court Administrator regarding Grants-in-Aid to Legal Services Organizations

The committee unanimously approved a recommendation of \$500,000.00 to the Chief Court Administrator as to the amount available from the client security fund for

the purpose of making "grants-in-aid" for delivery of legal services to the poor pursuant to Practice Book § 2-77.
