## **Diversity Week 2023**

Isabel Alvarez reported that the classes are being entered into the Branch's Learning Management System (LMS), and the Subcommittee expects to make the classes available for registration this Friday or Monday of next week. The Subcommittee will meet tomorrow and one of the items for discussion will be to decide who will deliver the opening remarks and introduce the keynote speaker at the Opening Celebration.

## Updates from the Office of Diversity, Equity, and Inclusion

- Troy Brown shared information from a course he recently completed: Strategies for Building and Leading a Diverse Organization. Using lessons from this training, Meghan Korn recommended this subject as a theme for Diversity Week 2024.
- Troy is conducting focus groups with the five Executive Directors, individually. Some of the Executive Directors requested that he conduct a focus group with their directors.
- Foundations in Cultural Responsiveness (FCR) 100 is still being offered once per month. The learner
  evaluations have been positive. There are two more sessions in 2023 scheduled for October and
  November. Troy relayed that there are more CSSD employees and contracted providers attending
  their sessions. He has mentioned this to the Executive Directors during their focus group hoping to
  increase participation by other divisions. Facilitator recruitment is still an issue and must be addressed
  if we hope to increase participation in FCR 100 classes.
- Lia Cestaro has been appointed to the Program Manager position in the DEI Unit.
- Troy drafted a memo to the Executive Directors concerning Public Act 23-133. "Latinx" is no longer an acceptable term for the gender neutral. The Branch's educational materials, forms, etc. should be changed from "Latinx" to "Latina, Latino or Latine."
- An e-mail will be sent soon to all Branch employees about Hispanic Heritage Month. The internal website will also be updated.
