Minutes Public Service and Trust Commission Jury Committee Selected Jurors Subcommittee January 13, 2009

The Selected Jurors Subcommittee of the Public Service and Trust Commission Jury Committee met at Middletown Superior, Court 1 Court Street, Middletown, CT in Courtroom 3B on January 13, 2009 at 2:00p.m.

Present: Dean Brad Saxton (chair), Hon. Nicola E. Rubinow (co-chair), Hon. Frank M. D'Addabbo, Jr. (liaison), Attorney Ernest Mattei, Attorney Cesar Noble, Attorney Michael Walsh

Not Present: Hon. Robert Devlin, Hon. Michael R. Sheldon (Judge Devlin and Judge Sheldon previously informed the subcommittee that they could not attend and submitted written comments.)

The subcommittee was called to order at approximately 2:10 pm by Dean Brad Saxton, chair of the subcommittee.

Dean Brad Saxton asked the subcommittee members who were present to introduce themselves.

- 1. Subcommittee members reviewed the subcommittee charges. Judge D'Addabbo confirmed that the subcommittee is not limited to the suggestions from the Jury Committee, but the template provided to all the subcommittees should be followed for drafting of the subcommittee report and recommendations. The subcommittee's fundamental goal is to explore and make appropriate recommendations for potential improvements in the treatments of selected jurors.
- 2. Dean Saxton provided the subcommittee with articles concerning selected jurors and jury trials. He asked all committee members to please review the materials for discussion at future meetings.
- 3. The subcommittee members discussed the possibility of conducting surveys and gathering information from jurors who served on trials; but the issue was reserved for future decision. The subcommittee will evaluate whether or not time will permit efforts to obtain this type of information.
- 4. The subcommittee reviewed and revised a preliminary list of issues and practices relating to treatment of selected jurors, in an attempt define the scope of the subcommittee's future discussions and recommendations. The list was compiled from examination of the subcommittee's charge and the recommendations set forth in the

American Bar Association's 2005 report "Principles for Juries and Jury Trials" (hereafter "ABA Principles"). The revised list resulting from the discussions at the meeting is attached to these minutes as Attachment A. Attachment A includes with "strikethroughs" certain topics that the subcommittee discussed and resolved – for now – not to address in the subcommittee's final report and recommendations.

Dean Saxton requested that that all subcommittee members review Attachment A and the pertinent material in the ABA Principles and to come prepared to the next meeting – on February 2 – to begin subcommittee discussions on the advantages and disadvantages of the practices/innovations described on Attachment A.

The next Selected Jurors Subcommittee meeting will be Monday February 2, 2009 at 4:00 p.m. at Day Pitney LLP, 242 Trumbull Street, Hartford, CT.
