Quarterly Report of the Client Security Fund Committee

July - September, 2011

Pursuant to Practice Book §2-72(e), the following is a report of the activities of the Client Security Fund Committee for the third quarter of calendar year 2011:

#### I. Claims Filed

Thirteen (13) claims for reimbursement were filed with the Client Security Fund Committee during the quarter, for an annual total as of the end of the quarter of forty-seven (47) claims. The dollar amount of claims filed during the quarter was \$1,287,305.26 for an annual total of claims filed at the end of the quarter of \$2,553,773.09. The total number of claims pending before the committee as of the end of the quarter was fifty-two (52), with a total amount of claims pending of \$3,663,052.72.

#### II. Claims Approved

The Client Security Fund Committee approved reimbursement for seven (7) claims during the quarter. The Committee approved payments to the claimants in those matters in the amount of \$325,278.32. The annual total of claims approved by the committee was eighteen (18) as of the end of the quarter, with a total amount of payments approved of \$558,088.53.

The committee also denied fourteen (14) claims totaling \$368,709.71 during the quarter, for an annual total of forty (40) claims denied in the amount of \$1,291,227.88.

### III. Fund Activity

The client security fund received \$318,745.00 in collections from individuals obligated to pay the client security fund fee pursuant to Section §2-70 of the Practice Book during the quarter. The client security fund also received \$5,737.84 in interest on the fund, and \$35,238.81 in restitution from attorneys or former attorneys whose conduct resulted in payments from the fund.

After deductions for expenses, payments to claimants, and other charges against the fund, including \$52,500.00 paid to the Lawyers' Assistance Program pursuant to Practice Book Section 2-73(f), the available cash balance in the fund as of the end of the quarter was \$12,405,385.90. A copy of the quarterly reconciliation of the client security fund prepared by the Judicial Branch Fiscal Administration office is attached.
