**Annual Report of the Client Security Fund Committee** 

Pursuant to Practice Book §2-73(a), the following is a report of claims filed with the Client Security Fund Committee during calendar year 2011, and on the committee's activities during 2011 in connection with claims filed with the committee.

## I. Claims Filed

During 2011, sixty-three (63) claims for reimbursement were filed with the Client Security Fund Committee. By comparison, seventy-nine (79) claims were filed in 2010. The total dollar amount of claims for reimbursement filed with the fund during 2011 was \$3,106,874.28 as compared with \$2,642,380.76 in claims filed during 2010.

## II. Activity on Claims

During 2011, the Client Security Fund Committee approved payments to claimants in twenty-three (23) claims filed with the Committee. The total dollar amount of reimbursement approved during 2011 was \$571,065.53. A list of the names of attorneys whose conduct resulted in awards of reimbursement during 2011, and the amounts awarded, is attached hereto. Fifty-five (55) claims were also denied during 2011.

At the end of calendar year 2011, forty-eight (48) claims remained pending, in the total amount of \$3,730,354.31, as compared with sixty-one (61) claims pending at the end of calendar year 2010 in the amount of \$2,955,589.11.
