THE MOST SUCCESSFUL WOMEN'S HOLISTIC HEALTH SESSION TO DATE

Among Community Court defendants with the most complex social needs are persons accused with the crime of prostitution. In addition to their legal matters, persons involved in prostitution are often struggling with a combination of significant substance abuse, physical and mental illness, post traumatic stress disorder, and a lack of safe housing and other resources.

With those obstacles in mind, the Community Court is pleased to announce that the February 2005 Women's Holistic Health Program class was the most successful session to date, graduating all five of the participants who started the program - the first time 100% of the participants have graduated. Designed as a way to introduce women to a way out of prostitution, the Women's Holistic Health Program consists of

two weeks of classes focusing on physical and mental health, overcoming triggers to destructive behavior, developing and implementing plans to successfully lead healthy lives, and reconnecting with available services. The women participating in the program also are required to perform court-supervised community service and comply with random drug testing.

The program, conducted on-site at the Community Court, is facilitated by Diana Desnoyers of Paul & Lisa, Inc., national leaders in helping sexually exploited women and children. Diana is assisted by her Paul & Lisa colleague Denise Holloman, Yanira Rodriguez and Lynn Bryant of the City of Hartford's Department of Health and Human Services, and Kaye White of ProjectAIDS Hartford (not pictured).

"The Court is very proud of the five women who graduated from the February Women's Holistic Health Program," Judge Simón said. "The women showed up for each class, they worked hard, and they stayed drug free. I am very impressed with their success and wish them well as they begin their lives anew."

The Community Court in Hartford would like to bid a fond farewell to Judicial Marshal Gordon "Gordy" Blanchette who is retiring at the end of February 2005 after 18-and-a-half years as a special deputy sheriff and judicial marshal, including over six years of service at the Community and Housing Courts at 80 Washington Street.

Prior to his service in the courts, Gordy served in the United States Marine Corps from 1953 to 1977 seeing duty in Korea and Vietnam. After retiring from the service, Gordy worked for the Town of East Hartford before becoming a sheriff.
