EXPANDING THE COMMUNITY COURT'S UNDERSTANDING OF DRUG TESTING

In an effort to improve their ability to help those in need, the Community Court staff constantly seeks to be educated on new concepts and ideas in care. As part of this effort, the Community Court was pleased to host a presentation by Chris Kochis of the state Department of Mental Health and Addiction Services/Capitol Region Mental Health Center concerning the effects of drugs on the body and the various schools of thought on treatments. Mr. Kochis was joined in the presentation by representatives from the Judicial Branch's contracted drug test provider and drug testing laboratory, who provided a great deal of background on the science and procedures of drug testing.

The Community Court in Hartford mandates drug testing for some defendants, including those involved with the court's Women's Holistic Health Program or young offenders under the supervision of the bail commissioners. Those who fail to comply with court orders to stay free of drug use may face court sanctions including incarceration. The serious implications of failing a drug test have motivated the court to review its standards and procedures to ensure the integrity of its drug testing procedures.

"When I put a defendant in a court program, I hold them to a high standard when it comes to staying drug-free," Judge Simón stated. "Conversely, I also hold ourselves to a high standard to protect the rights and best interests of our defendants as we try to help them."

THE EBONY HORSE WOMEN EQUESTRIAN CENTER: A UNIQUE OPPORTUNITY IN HARTFORD

Hartford is home to many unique programs and opportunities. The Community Court in Hartford has been fortunate to work with many local organizations to put its defendants in touch with those opportunities. Among the most fruitful of those collaborations is a relationship the Court has enjoyed with the Ebony Horse Women Equestrian Center in Hartford's North End. For nearly four years, the Community Service to the equestrian center to work.

In its 21st year of operations, the Ebony Horse Women Equestrian Center is a non-profit facility that uses horses and a ranch environment as a youth development tool for local youngsters.

"A lot of the children we see are wounded because of problems with school, their families, or just life in general," said Patricia Kelly, Executive Director of the Ebony Horse Women Equestrian Center. "Horses heal the spirit, test the body, and challenge the mind."

"We teach the kids if they can control their mind and their body, they can control the horses, but you can't do it if you are not in control." Mrs. Kelly continued. "By working with the horses the kids learn that they might not be able to change the conditions of their life but they can develop skills to handle them."

In addition to riding the horses at the Ebony Horse Women Equestrian Center, kids learn about animal husbandry and the inner workings of a horse ranch. The equestrian center also offers after-school programs for local students, tutoring classes in math and English, and a leadership program that guides youngsters to becoming effective leaders.

"We are grateful to the Ebony Horse Women Equestrian Center for providing a forum in which some of our defendants can perform community service," Court Coordinator Chris Pleasanton said. "Many of our defendants who worked there have remarked that it was a unique experience and that they felt it was a positive way to give back to the community."
