COMMUNITY COURT PARENTHOOD PROGRAM

In an effort to provide young parents who come before the court with parenting information, the Community Court in Hartford initiated its first parenting class this summer. Developed with the assistance of Lisa Davis of the State Department of Public Health and Horace McCauley of the State Department of Social Services, the program consisted of five sessions focusing on physical and emotional development of infants, nutrition, child safety, and setting goals as a parent.

"From the bench, I see too many kids who have kids," Judge Curtissa Cofield said. "It is my hope that we can use their involvement with the court to enhance their parenting skills."

Working in collaboration, Ms. Davis, Mr. McCauley, and Court Coordinator Chris Pleasanton arranged for different speakers for each session, including Megan O'Hanlon of Community Health Services and Marian Storch and Charlie Slaughter of the State Department of Public Health.

"We are very grateful to the speakers who volunteered their time and expertise," Chris Pleasanton said. "Because of their efforts, four young parents were able to participate in and graduate from our program."

ABH - DMHAS VETS PROGRAM WORKING WITH COMMUNITY COURT

With an ever increasing number of Connecticut's military service members serving deployments in Afghanistan and Iraq, the State Department of Mental Health and Addiction Services and Advanced Behavioral Health, Inc. are working together on the Military Support Program to provide help to those service members and their families before, during, and after their deployment. Services include help with veterans' benefits and entitlements, mental health and stress issues, substance abuse treatment, and employment and educational programs.

Realizing that some people who qualify for assistance from the Military Support Program may have involvement with the criminal justice system, sometimes as a result of the stresses of military service, MSP representatives recently met with staff from the Community Court to make their services more readily available to those in need.

"The Community Court is grateful for the Military Support Program's efforts to help those who have served our country face the unique challenges their service presents," Judge Cofield stated.

Bail Commissioners' duties include checking a defendant's prior criminal history, making bond recommendations to Judges, and performing supervision of some clients.

"I am pleased for Nate that he has been recognized with this promotion," Judge Cofield said. "His hard work and experience add greatly to the quality of the Community Court."

Nate is also a verteran of two military tours in the Middle East and his son William is currently deployed in Iraq.

'MAD DOG' SPEAKS AT THE COMMUNITY COURT

The Community Court strives to provide educational opportunities for all who come before the court. Those opportunities come in many forms, whether through formal classes, having a heart-to-heart conversation with a social worker or by working on a community service project. One of the most unusual educational opportunities presented itself when Dale "Mad Dog" Messmer came to Hartford.

Mr. Messmer is a former United States Marine who went from being a millionaire businessman to jail due to piloting drugs into the United States. After being released, Mr. Messmer chose to share his experiences with as many young people as he can so they don't make the same bad choices he did. He currently travels the country speaking to young people at schools, community centers, and is a frequent quest on television's "The Maury Povich Show." He speaks in a straightforward manner, without being obscene or offensive, yet still "tells it

like it is" as only someone who has been there can. In addition to speaking at the Community Court, Mr. Messmer also spoke at several Hartford-area schools and youth programs.

"I see too many kids who are drawn by the fast money and so-called glamour of the street life, but the reality is the whole stop-snitching gang culture is a dead-end street" Judge Cofield said. "Mr. Messmer spoke eloquently and to the point on what those bad choices lead to, incarceration or death, and it isn't pretty. I could see his speech making an impact on many of those who listened to him"

My experience interning at the Hartford Community Court has been extraordinary and has cemented my decision to pursue a career as an attorney. I have observed the unique, progressive culture of the Community Court for the summer of 2007 and I have received an education that no class or legal education could offer. Working closely with Judge Cofield and Chris Pleasanton has been a fundamental part in making my experience as an intern fulfilling and educational.

Throughout my internship, I had the opportunity to work within various realms of the court including protocols such as the prostitution protocol, which was one of the most interesting. I was excited to go to court every day because there was never a mundane task or dull day at the Community Court. Judge Cofield's personal interest and professional approach to each case makes going to court a pleasurable experience as well as an entertaining one. I have had quite an influential and unique experience interning here at the Community Court and I have been blessed with having an ideal role model like Judge Cofield to influence me in my legal career. Judge Cofield's dedicated and proactive involvement in the community coupled with Chris Pleasanton's tact, experience and efficiency makes for the perfect team of community heroes and I am honored to have been their third wheel for the summer. Working with Judge Cofield and Chris this summer has given me hope in my desire to impact my community and work with individuals who are financially underprivileged but need representation. COMMUNITY COURT & SHELTERS WORKING TOGETHER

Over the years, the Community Court has developed good working relationships with several Hartford-area homeless shelters. This is due in no small part to the Court's participation in the Hartford-area Shelter Case Manager's monthly meetings, moderated by Mark Hightower of the CRT McKinney Shelter. In addition to Court Coordinator Chris Pleasanton representing the Court at each meeting, the Community Court has also hosted the meeting on two occasions.

Since opening in 1998, the Community Court in Hartford has handled many cases of individuals who are homeless or reside at an area shelter. The open lines of communication between the Court and the shelter case managers have resulted in improved services for the defendant clients and have reduced some of their involvement with the criminal justice system.



Mr. Hightower invited Mr. Pleasanton and John Sims of Advanced Behavioral Heath, Inc. to participate in a panel discussion at the Connecticut Coalition to End Homelessness' 6th Annual Training Institute at Manchester Community College on July 27th, Mr. Hightower, Mr. Sims and Mr. Pleasanton discussed the benefits of non-traditionally linked organizations working together and the unique opportunities it presents.

"Mark's invitation to the Community Court to participate in the case manager's monthly meetings has helped the court better serve the homeless shelter population it works with," Mr. Pleasanton said. "We have also been able to expand the service opportunities for our defendants by connecting with providers including ABH who also attend these meetings."
