A lack of resources, histories of substance abuse and mental health, unemployment and physical illness are just a few of the key issues they are facing. Although many qualify for the assistance and services they need, a large number are not connecting with that help on their own. For that reason, the Hartford Community Court cannot overstate the importance of our collaboration with the State Department of Social Services.</p> <p>Under the partnership between DSS and the Hartford Community Court, DSS Eligibility Caseworker Tamara Collins works on-site at the court each Tuesday. Ms. Collins meets with clients referred by the Court, DMHAS and the City of Hartford staff, who are in need of, and may qualify for, state services including food stamps, medical cards and other forms of assistance. Ms. Collins is connected by computer to the statewide DSS system and can determine a person's eligibility on-site. AMTRAK SAFETY CLASS

In the summer of 2013, 638 people were arrested or summonsed to the Hartford Community Court for criminal behavior during the concert season at the Comcast Theater and the surrounding parking lots. Of those, 118 people were arrested or summonsed for criminal trespass by the Amtrak Police because they wandered into the adjacent rail yard and train tracks. In prior years, several people who wandered onto the railroad property have gotten seriously injured, including fatalities. Others have attempted to damage railcars that contained hazardous materials.

In an effort to educate people who trespass in the rail yard, the Amtrak Police have collaborated with the Hartford Community Court to offer defendants the Amtrak safety class at the court. Amtrak Police Officers Robert Hanson and Cliff Tucker conducted two sessions of the safety class at the court this past summer. They conveyed to participants the many dangers associated with trains and crossing onto railroad tracks through video presentations and discussions. Many of the participants expressed a new-found respect for the dangers of railroads in follow-up essays they were required to write after the class.

Because many of the trespassers in the rail yard were doing so to avoid long lines for the portable restrooms in the independent parking lots, Assistant State's Attorney Tom O'Brien reached out to the lot operators to ask if they would increase the number of facilities in their lots.

STRIVE WEST HARTFORD VISIT

Students and teachers from West Hartford's STRIVE Program were welcome visitors to the Hartford Community Court on December 4. Nearly a dozen STRIVE students met with Judge Bradford Ward, Program Manager Chris Pleasonton, West Hartford Social Worker Joe Kalache and George Dillon of Community Health Services to learn about the community court and the justice system in Connecticut. They also learned about factors, including substance abuse and other illnesses that sometimes effect a person's involvement in criminal activity and how the court addresses those issues. The students then observed the court in session and had lunch with court staff.

The West Hartford STRIVE visit was the result of the longstanding collaboration between the Town of West Hartford Social Services Department and the Hartford Community Court. West Hartford provides the court with Social Worker Joe Kalache each Wednesday morning. Mr. Kalache interviews and assesses West Hartford defendants for their social services needs, makes referrals and follows up on their progress. Through this collaboration, Mr. Kalache worked with the court and STRIVE to arrange a visit to the court for the students so they could learn about criminal justice and the social services programs in their community. The student visit was made possible with funds West Hartford received from the Capitol Area Substance Abuse Council and distributes through the West Hartford Substance Abuse Council.

CHS HEALTH FAIR

In recognition of the 2013 National Health Center Week, on August 15 CHS held a massive outdoor health fair where local residents could connect with CHS services including blood pressure and HIV testing, eye-care and pediatric health care. People were also able to connect with other community service providers at the fair, including the MDC water cleanliness project and the Hartford Police and Fire Departments, among many others.

The Hartford Community Court sent several community service work crews, under the care of field supervisor Alice Gibbs and CPA Program Operations Director Deb Rogala, to assist with the event, helping to set up the tables, cleaning the area, and helping CHS representatives hand out free materials, including healthcare brochures and bottled water. The crews also helped break down and clean up at the conclusion of the event.

RESTITUTION

In some cases that come before the Hartford Community Court the defendant is alleged to have damaged property. Everything from broken windows, torn clothing and smashed yard fixtures to broken bicycles have been involved. As part of his offer to defendants in these cases, Assistant State's Attorney Tom O'Brien requires them to pay restitution to the victim, whose property was damaged. The restitution is paid through Bail Commissioner Tammy Niemann, who accepts a money order from the defendant and forwards the money order to the victim. Bail Commissioner Niemann and Attorney O'Brien track the cases in some of which the defendants make small monthly payments towards the restitution. In 2013 alone, over \$25,000 in restitution has been forwarded through Bail Commissioner Niemann.

"Restitution is an important tool for me to directly help a victim in some cases," Attorney O'Brien said. "For a person on a fixed or limited income, especially, the only way I can make them whole is by requiring restitution from a defendant for the property they damaged."

A VISITOR FROM NEW ZEALAND

Since his retirement in 2009, the Hartford Community Court's original prosecutor, Glenn Kaas, has stayed active in the legal community first by lecturing on restorative courts and alternative justice at Trinity College in Dublin, Ireland and also through his wife Carolyn Wilkes Kaas, who is a professor at Quinnipiac School of Law. As such, he met Dr. Annabel Taylor, senior lecturer and director of postgraduate studies at the University of Canterbury of Christchurch, New Zealand. Dr. Taylor is participating in an exchange program at Quinnipiac until February and became interested in the Hartford Community Court after listening to Glenn speak of the model and his years at the court and he quickly arranged a visit.

Dr. Taylor, along with Quinnipiac Prof. Linda Meyer, met with Judge Robert F. McWeeny, Program Manager Chris Pleasanton, Community Service Program Manager Deborah Barrows, Community Service Field Supervisor Geoffrey Greene and Assistant State's Attorney Tom O'Brien to discuss various aspects of the Hartford Community Court. She then observed the first morning session of the court and toured the facility.

PLANTING A SEED IN HARTFORD

Many of the best projects at the Hartford Community Court are the result of teamwork and collaboration. The court's newest project is an example of that. When the community service team was brainstorming new initiatives, Supervising Judicial Marshal Frank Lucca suggested a community garden where defendants performing community service could plant, maintain and harvest the garden and the food could be donated to the community. Program Manager Deborah Barrows reached out to Knox Parks Foundation, who agreed to rent a sizable plot of land to the Community Court in their community garden located at Barbour and Earl Street in Hartford's North End.

In order to prepare the garden for next spring, Assistant State's Attorney Tom O'Brien, Program Manager Chris Pleasanton and Community Service Field Supervisor Alice Gibbs spent an afternoon tilling the soil and remove rocks from the planting area. Ms. Gibbs has taken responsibility for the project and will personally supervise the community service crews working in the garden. Mr. Lucca, a very experienced gardener, has offered to consult with the team on planting cycles and farming techniques.

"The community garden project has the added benefit of having defendants who work on it experience what it's like to plant a seed, work the land and see the results of their work grow, plus the good feeling they will have helping feed people in the city," Mr. Pleasanton said. "It goes to the heart of our mission: to help people rebuild a sense of community."

"This community garden project represents the best of what the Hartford Community Court is. It's about a team coming together with ideas and going beyond the routine of our jobs to help the people we work with at court and the community as a whole."
