### A Guide to Juror Service for Members of the Military

# Q: Are members of the military automatically exempt?

**A:** Not automatically, however, your military service may result in you being excused on the basis of extreme hardship.

## Q: Who may be excused for extreme hardship?

**A:** Active duty military personnel serving out of state, on board a ship or overseas, or on a Connecticut military base during time of war may be excused on the basis of extreme hardship.

#### Q: May civilian personnel employed at a Connecticut military base be excused for extreme hardship?

**A:** Civilian personnel must report for jury service, however, jury service may be postponed to a more convenient date.

Q: I am not a Connecticut resident, but I am serving on a Connecticut military base. Am I required to serve as a juror in a Connecticut Superior Court?

**A:** No. Only legal residents of the State of Connecticut are eligible to serve as jurors in a state court.

Q: If I am serving overseas, or on board a ship, or out of state, or on a Connecticut military base during time of war, how may I be excused from jury service?

**A:** If you are overseas, or on board a ship, or out of state you may write a letter to the Jury Administrator that includes the following:

- Your branch of the military service
- Your rank and duty station
- Your expected date of return to Connecticut

If you are serving on a Connecticut military base during time of war, you may have your commanding officer write a letter to the Jury Administrator that includes the following:

- Your branch of the military service
- Your rank and duty station
- A statement that your continued presence on the base is essential to the war effort

### Q: How will I be notified that I am excused?

**A:** You will be notified via United States mail that you have been excused for one year due to extreme hardship.

#### **Q:** Is this excuse permanent?

A: No. You may be randomly selected to serve again during the following court year. If this occurs, you must re-apply to be excused for extreme hardship. A court year runs from September 1 through August 31 in any given year.
