1. Welcome and Introductions

Chair Linda J. Cimino called the meeting to order at 2:04 p.m. Committee members introduced themselves.

Denise Covington acknowledged the ten year anniversary of the SAFE Program. She reviewed the original intent which was to be a statewide rapid response program where trained forensic examiners would respond to hospitals. She discussed the barriers to hospitals to maintain their own trained staff to perform sexual assault forensic exams which include funding and issues related hospital emergency department staffing. Denise noted that hospital emergency

departments have become dependent on SAFE's to respond but very few want to be a part of the SAFE Program. Denise reported these issues were addressed at a recent meeting with participating hospital administration.

Committee members discussed methods to develop health care provider training as a core component.

Pat Moriarty discussed the feedback received from SAFEs after completing the fall training. She noted the comments from SAFEs emphasized the need for this specialized and continuing education.

Denise reported that the strategic planning committee formed from SAFEs within the program will brainstorm methods to have this type of training included as a core competency.

7. SAFE Training Program Update

Pat Moriarty reported that the deadline for registration for the spring class is March 15, 2021, and training begins on March 29, 2021. The anticipated spring class count is 20 students.

Pat reported that the continuing education unit application was approved by the International Association of Forensic Nurses, an accredited approver by the American Nurses Credentialing Center's Commission on Accreditation.
