1. Welcome and Introductions

Mary Kozicki, (Chair) called the meeting in order at 2:05 PM. Committee members and guests made introductions.

2. Approval of August 14, 2024 meeting minutes

3. <u>Update from SAFE Response Program Manager</u>

Rachel Henderson provided a SAFE Response Program update including:

International Association of Forensic Nursing (IAFN) State Coordinators meetings, and Experiential Testimony Training hosted by the University of New England.

Kim McKinnon provided a SAFE Training Program update including:

6. <u>Update on SAEC Kit Revisions and Technical Guidelines</u>

Mary Kozicki reported that the request for proposals closes on November 27th with the proposal review process to commence following bid closure. Continued revision of The Technical Guidelines will commence following the selection of a vendor.

It was confirmed that the request for suspect evidence collection utilizing a CT100 is a rare occurrence and does not require additional discussion.
