MUSEUM OF CONNECTICUT HISTORY

Housed in the 1910 State Library and Supreme Court Building, the Museum of Connecticut History consists of Memorial Hall, a magnificently restored beaux-arts style gallery and three adjoining exhibit areas. On permanent display are portraits of Connecticut Governors as well as historic documents, including the State's original 1662 Royal Charter, the 1639 Fundamental Orders and the 1964 State Constitution.

The focus of the Museum and its collections is Connecticut's government, military and industrial history. Permanent and changing exhibits trace the growth of the State and its role in the development of the nation from the Colonial era to the present.
