

## **Changes to Document Titles (Legend Codes) Available in E-Filing**

The document titles (legend codes) used in e-filing *in civil cases* will change April 1, 2013. The legend code selected when e-filing a document determines if and when it will appear on a short calendar, and if it will be brought to the attention of a clerk. Therefore, it is important that filers choose the correct legend code when e-filing a document.

The following changes have been made for e-filing in *civil cases*:

- (1) Family-specific legend codes have been removed from e-filing;
- (2) Other duplicative legend codes have been removed; and
- (3) New legend codes with a more detailed description of the document, a reference to the appropriate Practice Book section or a form number, if a form is available, have been added.

Separate lists of legend codes that are no longer available and that have been added are provided below.
