## **LIBERTY BELL AWARD 2014**

This year's Liberty Bell Award recipient is Dritan Mersini, who works as an office clerk at the G.A. #18 in Bantam.

Dritan was born in the small town of Struga, Macedonia. He immigrated to the United States with his parents when he was 2 years old from a country high in poverty that offered very little education or employment opportunities. Growing up, his parents, Milaim and Baftisha, instilled in Dritan and his brothers a strong work ethic and a desire to learn. Dritan learned the English language and became a citizen of the United States. He earned his Associates Degree in paralegal studies from Naugatuck Community College and then went on to earn his bachelor's degree in Criminal Justice from Central Connecticut State University in 2009. He came to the Bantam G.A. in December of 2009 as an Office Clerk. Outside of the office, he enjoys reading, learning, and being a handy man. In addition, Dritan has worked construction, as a security officer, and with children at amusement parks.

Dritan was the unanimous choice to receive this year's award because of the wonderful job he does each and every day. Whether working with his co-workers, attorneys or self represented parties, Dritan is respectful, informative, and courteous. He is the consummate professional: efficient, hard-working, and is always ready to go the extra mile to get the job done.
