**Instructions to Petitioner**

1. Prepare this petition and give the original and one copy to the clerk, along with the required fee. The clerk will review the petition and schedule a hearing date that is within 30 days. The clerk will sign the petition and give you a copy that contains the Court Hearing Date and Time.
2. Mail a copy of the petition that contains the hearing date and clerk's signature to the Executive Director of the Commission on Human Rights and Opportunities and every person named in the discriminatory practice complaint. You must mail these copies by certified or registered mail, return receipt requested at least 20 days before the hearing date set by the clerk.
3. After you mail the copies of this form, complete the Affidavit of Service (form JD-CV-69), attach the return receipts from your mailing, and file with the clerk not later than five days after the copies were mailed.

**Notice Of Hearing To Commissioner On Human Rights And Opportunities And Persons Named
