**Special Instructions**

1. You are to keep this Travel Permit on your person at all times while outside the State of Connecticut.
2. You are not to travel to any jurisdiction other than authorized by this Travel Permit unless travel to such a jurisdiction is normally required when travelling by the means of transportation noted above to the destination noted above.

You are to register as a sex offender with an appropriate law enforcement agency in the receiving jurisdiction, provided such jurisdiction has a registration requirement for sex offenders, and you are to register your new address with the Connecticut Commissioner of Public Safety within five (5) days of any change in your address.

**Probationer's Agreement**

In consideration of this privilege, I shall return as noted, unless a transfer of supervision is arranged and further agree that:

1. I will comply with probation rules and regulations of both states.
2. I will waive extradition to the State of Connecticut from any jurisdiction in or outside of the United States, and also agree that I will not contest any effort by any jurisdiction to return me to the State of Connecticut.
3. Any changes in my travel or other information must receive the prior approval of my Probation Officer.
4. My failure to abide by all of the instructions and agreements in this Travel Permit or my knowingly providing false information in connection therewith may result in the revocation of this Travel Permit and my prosecution for a violation of probation.
