Instructions To Probation Officer

1. Complete part 1 in full when probationer is presented to nearest correctional facility. Attach a copy of sending state's Order of Probation and one copy of arrest warrant to the original of this form and leave at correctional facility.
2. If a copy of NCIC teletype is used in place of an arrest warrant, deliver copy of arrest warrant to correctional facility upon receipt from sending state.
3. Retain copy of the form, 2nd copy of arrest warrant and all materials pertaining to detention, incarceration and a record check in probationer's case file. Upload to Interstate Compact Offender Tracking System (ICOTS).
4. Complete part 2 on original (Department of Correction) and copies (Adult Probation) when representative(s) of sending state take custody.
5. If the probationer has pending charges, he or she will not be retaken by the sending state until all charges have been dismissed, sentence has been satisfied or the probationer has been placed on probation for the subsequent offense. When custody is not taken by the receiving state within 30 calendar days from the date the probationer becomes available for retaking, the APO will complete Part 3 on both copies of this form, leave the original at the correctional facility, retain a copy in the local case file and upload a copy into ICOTS.

Part 1 — Order Of Incarceration

Pursuant to Section 54-133 of the Connecticut General Statutes concerning Interstate Compact matters, the probationer named above, transferred to the jurisdiction of CSSD/Adult Probation, Connecticut Judicial Branch, is hereby placed in the custody of the Connecticut Department of Correction by order of the sending state court. Attached is a copy of the arrest warrant (or authorized NCIC teletype) from the sending state.

The probationer shall remain in custody and be held without bond until the sending state authorities retake the person by establishing the authority of their officials and the identity of the probationer to be retaken; or this order is revoked by the court or withdrawn by the CSSD/Adult Probation.
