Pursuant to Interstate Commission for Adult Offender Supervision Rule 4.109-1 Authority to arrest and detain: *"An offender in violation of the terms and conditions of supervision may be taken into custody or continued in custody by the receiving state."*

Pursuant to Section 53a-32(a) of the Connecticut General Statutes, the above-named offender is hereby remanded to actual custody at the facility listed above. Section 53a-32(a) as amended by P.A. 10-43 section 20 states, in part: *"Any Probation Officer may arrest any defendant on probation without a warrant or may deputize any other officer with power to arrest to do so by giving such other officer a written statement setting forth that the defendant has, in the judgement of the probation officer, violated the conditions of the defendant's probation. Such written statement, delivered with the defendant by the arresting officer to the official in charge of any correctional center or other place of detention, shall be sufficient warrant for the detention of the defendant."*
