**The court has ordered that you take part in a nonconfrontational forum to hear from victims who have been affected by underage drinking, drunk driving, distracted driving, or other motor vehicle violations for the Under 21 Motor Vehicle/Underage Drinking Program.** The approved forum is through the Mothers Against Drunk Driving (MADD) SMART™ Program

- 1. You must go to and finish the next MADD SMART Program forum listed below.**
2. You must register at the MADD SMART Program location during the registration period that starts 45 minutes before the forum starts. You cannot register before that time.
3. You must pay MADD \$50.00, using a money order or cashier's check (**cash or personal checks will not be accepted**), payable to *MADD Connecticut*, on the day of the meeting.
4. You must bring a photo I.D. to be allowed into the forum.
- 5. You will not be allowed into the forum after it starts. Do not be late.**
6. MADD requires a parent or guardian to go to the forum with anyone under the age of 18. If your parent or guardian goes to the forum with you, your parent or guardian must pay the \$50.00 fee using a money order or cashier's check and follow the program rules as well.
7. When you finish the forum, MADD will give you a certificate saying that you finished the MADD SMART Program. You must give a copy of this certificate to Bail Services. It should be mailed to CSSD, Bail Services, at the *Address of Court* listed above or faxed to the *Bail Services office fax number* listed above.
