Instructions to law enforcement officer

1. Complete this form when money or stolen property is seized: (a) in connection with a criminal arrest, or (b) pursuant to a search warrant without an arrest.
2. Complete this section of the form in triplicate. Retain a copy.
3. Give a copy, at the time of seizure, to: (a) the person or persons from whom the property was seized, or (b) to the person or persons having a possessory interest in the premises from which such property was seized. Have the person(s) to whom you have provided this receipt at the time of seizure verify the property seized by signing below. In the absence of such signature(s), whether because of refusal to sign or absence at the time of seizure, have the supervisor(s) of the law enforcement official(s) who effected the seizure sign below.
4. If property was seized from premises in the absence of the person or persons having a possessory interest therein, mail a copy of this receipt to such person or persons by registered or certified mail within five days of seizure.
5. If the seized property is stolen property, send original form to owner of property within 10 days of seizure. If owner is unknown at time of seizure, send original form within 10 days of identification of owner.

Notice and Advisement of Rights To Owner Concerning Seized Property

TO: Owner of seized property or money

The property or money listed on the front of this form (page 1) has been recovered or seized by the law enforcement agency listed on the page 1.

If that property or money is stolen property, you can ask that the property or money be returned to you. When you ask for the return of stolen property or stolen money, the court must order the police to return the property or money to you within thirty (30) days, or the court may order that the property or money be kept for a period of time that the court sets.

If any of the money recovered or seized is not stolen property, the person from whom the money was seized can, within thirty (30) days of getting this notice, ask for a court hearing to decide what will happen to the money. The court may order that the money be deposited into an account that keeps track of amounts of money that are evidence in court cases, or may order that the money be kept for a period of time that the court sets.

To ask for the return of stolen property or money that was not stolen: Fill out the information in the Request section below, check the right box for the return of stolen property or money or a hearing on money that is not stolen property, sign the form, and bring it or send it to the law enforcement agency at its address listed on page 1.

If you do not bring or send this form to the law enforcement agency to ask for the return of stolen property or money or to ask for a hearing on money that is not stolen property, two things may happen. If there is a criminal case related to the property or money, the property or money may be kept until the end of the criminal case. When the criminal case is over, the court will order the property or the right amount of money to be returned to you unless the court decides that the property is not something that can legally be returned to you because it is a nuisance, contraband, controlled substance, or drug paraphernalia. If there is no criminal case, a prosecutor will make a motion telling the court that there is no criminal case, and the court will order the property or the right amount of money to be returned to you.

Once the court orders that property or money be returned to you, you must pick up the property or money from the law enforcement agency that is keeping the property or money within six (6) months of the court's order. If you do not pick up the property or money within that time, the property or money will be disposed of according to the court's order.
