I have a right to refuse to make any statement, and any statement that I make may be introduced in court against me.</p> <p>c. I have a right to be admitted to bail.</p> <p>2. I also understand that, if I have been previously convicted of a similar offense, I may be presented as a second or subsequent offender. I hereby agree that I may be so presented, and I hereby expressly waive my right to any other notice prior to plea.</p> <p>3.
