Waiver And Release

I, the undersigned, the above-named defendant, hereby acknowledge that I have been informed by the Judge above-named, on the above-captioned date, that:

1. Demand has been made for my surrender to the Demanding State above-named;
2. Said Demanding State charges me with having committed the above-specified Crime(s) Charged; and
3. I have a right:
 - a. to demand and procure legal counsel;
 - b. to test the legality of my arrest;
 - c. to have my case continued for a reasonable time within which to apply for a writ of habeas corpus; and
 - d. to require the issuance and service of a Warrant of Extradition by the governor of this state.

Having been informed as stated above, of my own free will and accord and without threat of penalty or promise of reward, I:

1. Consent to return in custody to the Demanding State for the purpose of answering to the above-specified Crime(s) Charged;
2. Consent to my delivery to the duly accredited agent or agents of the Demanding State;
3. Waive the issuance and service of the aforesaid Warrant and all other extradition proceedings; and
4. Release the State of Connecticut and all of its officers and agents, and each Town of said State and all of its officers and agents, from any claim or cause of action arising out of my arrest and detention in connection with the present proceedings.

Certification And Order

The undersigned, a Judge of the Superior Court, hereby certifies that :

1. Said Court is a Connecticut court having criminal jurisdiction;
2. Before the above-named defendant executed the foregoing Waiver and Release, the undersigned informed said defendant of his/her rights to the issuance or service of a Warrant of Extradition and to obtain a writ of habeas corpus, as provided by law; and
3. After having been so informed, said defendant voluntarily agreed to return to the Demanding State and executed the foregoing Waiver and Release in my presence.

Wherefore, the undersigned hereby directs the officer having the said defendant in custody to deliver forthwith said defendant to the duly accredited agent or agents of the Demanding State, together with a copy of the foregoing Waiver.
