Order To Incarcerate For Failure To Serve Sentence

You are commanded to deliver the offender to the Commissioner of Correction or the Commissioner's agent at the correctional facility. If the offender is sentenced to a term of imprisonment and ordered to pay a fine, the offender may not continue to be incarcerated beyond the time the sentence has been served unless the judicial authority has found that the offender is able to pay the fine and that the offender's nonpayment is willful.

Order To Incarcerate For Nonpayment Of Fine

The court finds that the offender is able to pay the fine imposed and that the nonpayment is willful, and orders the offender to be taken into custody and incarcerated for nonpayment of the fine.

Total Fine (Unpaid balance only): \$ _____

The offender is ordered to be committed to the Commissioner of Correction or the Commissioner's agent at the correctional facility for non-payment of fines as shown above. (*An offender may not be incarcerated for failing to pay fees or costs*). The offender shall be released upon payment of the fine or when the offender is otherwise discharged according to law.

The Commissioner of the Department of Motor Vehicles may suspend the offender's motor vehicle operator's license for not paying certain court costs, in addition to the total fine above. To avoid a suspension in this matter the offender also must pay the following
