Instructions to law enforcement officer:

1. Complete and mail this Notice form to subscriber/customer within 48 hours of issuance of an order to disclose telephone or internet records unless court orders a delay of notice. If court orders a delay of notice, send this Notice within time period set by the court.
2. File a copy of this notice, along with any order extending the delay of notice to the subscriber/customer on form JD-CR-177, Request to Extend Delay of Notice for Order to Disclose Telephone or Internet Records, with the clerk of the court for the geographical area within which any person who may be arrested in connection with, or subsequent to, the issuance of the order to disclose telephone or internet records would be presented.

Notice to Subscriber/Customer

- ☐ Call-identifying information, which means dialing or signaling information that identifies the starting point, direction, destination or end of each communication created or received by you through any equipment, facility, or service of a telecommunications provider.
- ☐ Basic subscriber information, which could include: your name; address; local and long distance telephone connection records or records of session times and durations; length of service, including start date, and types of services you use; telephone or instrument number or other subscriber number or identity, including any assigned Internet protocol (IP) address; and any source of payment for the service that you use, including any credit card or bank account number.
- ☐ The content of your communications.
- ☐ Geo-location data related to your call-identifying information, which means information about the location of an electronic device, including the real-time and historical (past) location of the device, that, in whole or in part, is created by, derived from, or obtained by the operation of an electronic device, including, but not limited to a cellular telephone surveillance device.
