Instructions

Upon confirmation and prior to the commencement of your new term, you must take the oath of office in accordance with Section 1 of Article Eleventh of the Connecticut Constitution and Sections 1-24 and 1-25 of the Connecticut General Statutes.

Oaths Administered Within the State of Connecticut - (C.G.S. Section 1-24)

Upon taking the oath of office, please have the person administering the oath complete the oath of office acknowledgement in its entirety as follows:

County:	County in which administered;
ss:	Location (city or town) where standing;
Date:	Date oath is administered;
Name:	Proper name of the judge taking the oath;
Town of Residence:	Town in which the judge resides; and
Position Appointed:	Title of position (as taken from the Governor's nomination or reappointment letter).

The oath of office acknowledgment form must be signed by the person who administers the oath of office.

If a notary public administers the oath, he or she must affix the notary's seal or type or print legibly the words "Notary Public" near the notary's official signature and indicate the expiration date of the notary's commission.

Oaths Administered Outside of the State of Connecticut - (C.G.S. Section 1-57)

If the oath is taken outside of the State of Connecticut, it must be administered and acknowledged by a notary public who must affix his or her seal, or by any of the individuals identified in C.G.S. Section 1-57 et seq. and authorized by the law of that jurisdiction to administer oaths and take acknowledgments.
