Notice To The Person Summoned

You must report to the court at the time and address shown above and remain until this case is disposed of and you are discharged by the court. Present this subpoena when you report. Your statutory fees as witness will be paid by the clerk of the court where you are summoned to appear, if you give the clerk this subpoena on the day you appear. If you do not appear in court on the day and at the time stated, on the day and at the time to which your appearance may have been postponed or continued by order of an officer of the court, the court may order that you be arrested. In addition, if you fail to appear and testify, without reasonable excuse, you shall be fined not more than twenty-five dollars and pay all damages to the aggrieved party.
