What does Emancipation mean?**For the minor that is emancipated, it means that:**

- (a) He or she may consent to medical, dental or psychiatric care, without the consent of his or her parent, and without the parent knowing about it or being responsible for it.
- (b) He or she may enter into a binding contract;
- (c) He or she may start a lawsuit by himself or herself and be sued;
- (d) He or she is entitled to the money he or she earns and his or her parent or guardian cannot control it;
- (e) He or she can decide where to live;
- (f) He or she may buy and sell property;
- (g) He or she may not be the subject of:
 - (1) a petition as an abused, neglected or uncared for child or youth, under section 46b-129 of the Connecticut General Statutes,
 - (2) a petition under section 46b-128, or 46b-133 as a delinquent child for any act committed before the date of the order, under section 46b-128, or 46b-133 of the Connecticut General Statutes,
 - (3) a petition alleging that the minor is a child from a family with service needs, under section 46b-149 of the Connecticut General Statutes,
- (h) He or she may enroll in any school or college, without the consent of his or her parent;

- (i) He or she is considered to be over 18 years old for:
 - (1) getting a driver's license under section 14-36 of the Connecticut General Statutes,
 - (2) getting a marriage license without the consent of his or her parent under section 46b-20(a) of the Connecticut General Statutes, or
 - (3) registering a motor vehicle under section 14-12 of the Connecticut General Statutes;
- (j) He or she may execute releases in his or her own name;
- (k) He or she may enlist in the armed forces of the United States without the consent of his or her parent; and
- (l) He or she may access or receive a certified copy of a birth certificate under section 7-51 of the Connecticut General Statutes.

For the parent of the minor that is emancipated, it means that:

- (a) The parents are not the guardians of the minor any more under section 45a-606 of the Connecticut General Statutes;
- (b) The parents are not responsible for the minor's attendance at school any more under section 10-184 of the Connecticut General Statutes;
- (c) The parents do not have to support the minor any more;
- (d) The parents are not responsible for the minor's acts under section 52-572 of the Connecticut General Statutes.
