**Instructions:**

The original Order of Transfer, Petition/Information (and the original warrant and/or PTA/Summons) shall be delivered to the Clerk of the Superior Court where the child will be presented. In cases where the child is in the care and custody of the juvenile residential center, a copy of the Transfer Order and the completed Detention Order and Mittimus, should be delivered with the child to the designated Juvenile Residential Center Superintendent.

The child named above was 15 years old or older on the date of the alleged offense, and was charged on the petition listed above with at least one:

After a hearing upon motion of a prosecutorial official conducted at the Superior Court for Juvenile Matters, the court finds:

the offense was committed after the child attained the age of fifteen years;

there is probable cause to believe the child committed the act for which the child is charged; **And**

the best interests of the child and the public will not be served by maintaining the case in the Superior Court for Juvenile Matters.

Any motion shall be made and any hearing shall be held not later than thirty days after the child is arraigned in the Superior Court for Juvenile Matters

**Or**

The proceeding has been designated a serious sexual offender prosecution; and

the child does not waive the right to a trial by jury.

## Transfer Order

Based on the offense(s) alleged against the child, the case is automatically transferred from the Superior Court for Juvenile Matters to the regular docket of the Superior Court **Or**  
 The request of the prosecutorial official for a discretionary transfer of this case is granted.

IT IS THEREFORE ORDERED, under section 46b-127 or section 46b-133d(f) of the Connecticut General Statutes that the child be transferred to the regular criminal docket of the Superior Court for prosecution as an adult **Or**

The request of the prosecutorial official for a discretionary transfer of this case is denied.
