Instructions to Judicial Marshal Services' Administration Official responsible for completing the following checks on a prisoner who is the subject of a civil immigration detainer.

1. Complete the identifying information at the top of the form.
2. Attach civil immigration detainer (and warrant, if applicable).
3. Perform each of the checks listed and indicate the result and any other required information.
4. Review the results with the Director of Judicial Marshal Services, the Deputy Director or a designee for this purpose who will make the final decision to release or detain.
5. Note the decision and make sure all required signatures are on the form.
6. Provide all required notifications and document each below.
